This membership agreement between Path of Life Healing Center and (**Member:** _____) shall be effective on the date of (**date purchased:** _____). Monthly payments for this membership shall occur on the day of each month that you signed up and made your first payment through the PayPal gateway. Path of Life is a PayPal merchant which charges your account automatically each month in the amount of initial your choice: _____ \$75.00 for one service or _____ \$170 for two services.

1. **The membership period** shall be for a period of twelve months (the “entire Period”, with a “probationary Period” of three months). **Note: You can enjoy the same service each month, or you can vary your service each month.** A member shall be entitled to terminate or suspend his/her membership at any time. 2. After the Probationary Period, the membership shall continue for nine months. After the Entire Period, the membership shall continue month to month until either party cancels the membership at any time by giving written notice to the other party (a text message can serve as written notice). (**Date terminated:** _____). 3. This Agreement is personal to the member and may not be assigned, transferred, or otherwise disposed of by the member. 4. Applicants for membership must be at least 18 years old. **Automatic Payment Agreement:** 1. Monthly membership payments shall be made in advance by direct debit from the member’s designated credit/debit account by PayPal payment systems. Personal information will not be kept on file by Path of Life Healing Center. 2. Path of Life Healing Center reserves the right to review subscriptions/memberships periodically. Members will be given at least 30 days’ notice in writing (text or email) of any changes, which include: (i) any increase in membership fee, (ii) change in date of automatic withdrawal. **Termination or Suspension of Membership:** 1. Path of Life Healing Center reserves the right at any time to cancel or suspend the membership of any member in the event of the following: **a.** The member commits a serious breach of this Agreement and/or Path of Life Healing Center Rules and Regulations. **b.** Where any monies due to Path of Life Healing Center by the member remain unpaid for 30 days after its due date for payment. **c.** The member knowingly provides false details when applying for membership and the false declaration would have reasonably affected Path of Life Healing Center’s decision to grant the membership. **d.** If Path of Life Healing Center terminates the membership contract for any reason, they reserve the right to retain any monies received to cover any reasonable costs they have incurred as a result. 2. Membership may be suspended for up to three months on medical grounds. A medical certificate may be required to continue administering services and treatments.

Terms and Conditions:

1. Path of Life Healing Center reserves the right to vary, add or eliminate any of the services and facilities provided them from time to time.
3. Path of Life Healing Center reserves the right to close or modify facility hours with or without notice.
4. Membership may not be combined with any other promotional offer or promotional gift card.
5. Other services can be added on during the time of services booked if time permits and additional monies will be collected at time of service.
6. There are **NO HOLD-OVER SERVICES**. You must engage in your service for that month or forfeit the month. We **do not allow** you to miss a month and make it up another time. That is not our policy... To clarify and make it plain, **Services cannot be added to another month** if you miss a month. Thus, make sure you keep track of your months. **There are not exceptions to this rule.**
